Keynote Address

Innovative Best Practice Governance for the 21st Century

Jonathan H. Burroughs, MD, MBA, FACHE, FAAPL, President & CEO Burroughs Healthcare Consulting Network, Inc. - Glen, NH



As healthcare transformation compels organizations to transform both its business and care models, healthcare governing bodies will need to transform how it governs and oversees both the quality and cost effectiveness of the healthcare services provided. This presentation covers national "best practice" approaches that top performing governing bodies are utilizing to ensure that their organizations not only survive, but thrive in a radically altered business and clinical environment.

Dr. Jonathan H. Burroughs works with some of the nation's top healthcare consulting organizations to provide "best practice" solutions and training to healthcare organizations throughout the country in the areas of governance, physician—hospital alignment strategies, credentialing, privileging, peer review and performance improvement/patient safety, medical staff development planning, strategic planning, physician performance and behavior management, as well as ways in which physicians and management can work together in new ways to solve quality, safety, operational, and financial challenges through the creation of population health programs and clinically integrated networks. Dr. Burroughs serves on the national faculty of the American College of Healthcare Executives and the American Association for Physician Leadership, where he has been consistently rated as one of their top speakers and educators.

Stacy Cantu, CAE, CGT, Vice President, Chief Governance Officer, Texas Health Resources - Arlington, TX



A hospital board's responsibility is greater than ever. Hospital board members, both individually and collectively, must know their fiduciary duties and have an understanding of the environment in which their hospital must operate. This popular session was created for trustees serving in their first term on a hospital board. The session will review the legal duties of a board member, the board building cycle and ways to engage the community in the hospital, seven things every board should focus on as well as better meeting practices. Participants will leave

with tools and ideas to take back to their boardrooms, as well as governance best practices and an overview of the current healthcare landscape.

Stacy Cantu has served as vice president and chief governance officer for Texas Health Resources (THR) since December 2016. THR is a \$4 billion health system with more than 40 boards and committees. Cantu served as the President/CEO for Texas Healthcare Trustees (THT), a statewide association for board members of hospitals, from January 2007 to December 2016. During her tenure at THT, Cantu was responsible for launching the Healthcare Governance Certified Trustee program, overseeing the creation of self-study tools, establishing onsite education at member hospitals and achieving a 99% increase in revenue over her first five years. Cantu facilitates board strategic planning sessions and speaks around the country on governance topics. Cantu achieved the designation of Certified Governance Trainer in 2016 from BoardSource.

Session 1: How Small and Rural Healthcare Organizations Can Succeed in Healthcare Transformation

Jonathan H. Burroughs, MD, MBA, FACHE, FAAPL, President & CEO Burroughs Healthcare Consulting Network, Inc. - Glen, NH



The challenge for most rural organizations under fee for service is there are significant incentives to attempt to provide "all things" including more complex surgeries, ICUs, high margin testing/procedures etc. Whereas in the new global economy, most will be incentivized to become "micro-hospitals" with high performing population health services, home health, post-acute care, telehealth and e-health (connected to regional urban centers), and create retail outlets to replace high-cost EDs for healthy individuals with acute issues. This is a radically different model

that they will need to prepare for as the reimbursement methodologies rapidly evolve and cost plus reimbursement is further scrutinized in the face to true cost accounting.

Session 2: The Marijuana Experiment: Decisions for Healthcare Providers

Sharon Caulfield, Shareholder, Brownstein Hyatt Farber Schreck, LLP - Denver, CO



The drive to increase public access to marijuana and cannabis medicinals continues. The western United States has proven to be open to new approaches to marijuana regulation, but the changing cannabis landscape offers many untrodden paths. Federal and state enforcement priorities often differ on questions of patient access, the use of hemp products and cannabidiols, and caregiver participation in marijuana handling. This program will introduce trustees to the wide variety of cannabis medicinal products that are available, provide guidance about cannabis use

by employees and patients, and educate about the interplay between federal and state laws and regulations.

Sharon Caulfield's decades of experience in healthcare law and background in employment law allow her to advise healthcare clients in many aspects of regulatory compliance, operational effectiveness and good employment practices. Her practice

focuses on business and regulatory advice for all types of healthcare providers, ranging from critical access hospitals to academic medical centers and also including individual professionals. Caulfield engages in business planning, Medicare compliance oversight and reporting, HIPAA privacy and security policies, antitrust counseling, managed care organizational development and insurance contracting, fraud and abuse and Stark law counseling, provider credentialing and administrative matters under the HCQIA, tax exemption advice, governmental and critical access hospital regulatory compliance, and many other elements of healthcare provider operations.

Session 3: Addressing Unfortunate Truths: The Growing Problem of Provider Drug Diversion and Tactics to Manage Against It

Thomas M. Donohoe, Hall Render Killian Heath and Lyman - Denver, CO



Opioid addiction continues to be a significant problem in the United States, especially in rural communities, and healthcare providers are not immune from its reach. The resulting effect may be both damaging for community hospitals that employ these providers and the patients they serve. This presentation will address the unique legal, regulatory and practical risks provider drug diversion presents for hospitals and how hospital governing boards may assist their organizations and administrations in managing these risks.

Tom Donohoe is an attorney with the nation's largest law firm dedicated to health law and advises hospitals on a wide range of transactional, regulatory and operational matters. He has particular experience in advising rural healthcare providers on the unique issues they may face. Donohoe graduated cum laude from Indiana University Robert H. McKinney School of Law in 2008 with a concentration and honors in healthcare law. He is admitted to the bar in Indiana, Colorado and Montana.

Keynote Address

The Board's Role in Quality and Patient Safety

John J. Byrnes, MD - Grand Rapids, MI



Boards play a critical role in advancing quality and safety. Some boards are engaged, and others just aren't. Top performing organizations have boards that actively lead, support and advance quality and safety. In this presentation, Dr. Byrnes will share how to get your board fully engaged and what results when you do.

- Describe five (board-driven) tactics that will directly improve quality and safety.
- Prioritize their quality initiatives that will move their organization to the top of the national ratings.

Dr. John Byrnes is widely recognized as one of the nation's leading experts and consultants on quality, safety and physician-hospital relationships. His presentations and workshops are dynamic and immensely practical—always motivating his audience to create a culture of excellence that delivers world-class clinical outcomes. Many of his clients have obtained the prestigious 100 Top Hospital and 15 Top Health System designations. Dr. Byrnes has held senior executive positions at some of the nation's leading healthcare systems, including Spectrum Health System, Sharp HealthCare, Catholic Healthcare West and Lovelace Health Systems.

Dr. Byrnes has over 20 years of practical experience leading, developing and implementing quality and safety programs in hospitals, medical groups and integrated healthcare systems throughout the United States and Europe. During his 10-year tenure as chief quality officer at Spectrum Health, the organization received over 100 quality awards and was twice ranked as one of the 10 Top Health Systems in the nation. Also an early pioneer in disease management and population health, Dr. Byrnes led the development of the award-winning Episodes of Care™ program that is now a foundational element of bundled-payment and patient-centered medical home initiatives.

Session 4: Hospital Finance 101

Carla Neiman, CHFP, CFO & Risk Manager, Clark Fork Valley Hospital - Plains, MT



This session will provide an introduction to hospital finance geared to trustees. We will discuss the role of finance with respect to governance and quality, introduce unique concepts in hospital finance, review standard financial reports and metrics, and discuss current trends in healthcare finance. Objectives include:

- Understanding the role of finance in your hospital's successful pursuit of its mission.
- Understanding the impact of reimbursement methodology, cash flow, and the external environment on financial strategy and performance.
- Assessing financial results through reviewing financial reports and metrics.

Carla Neiman has been the CFO and risk manager at Clark Fork Valley Hospital in Plains, Montana since 2002. Prior to that, she held positions as director of communications and development, business office manager and special projects manager at the hospital. She served on the hospital's governing board for eight years prior to joining the staff. Neiman has a BS in business finance from MSU, Bozeman and a MHA from the University of Minnesota. She is active in the Montana Chapter of HFMA, serving currently as president-elect.

Session 5: Telemedicine: Who, What, Why & Where

Catherine M. Ballard, Partner, Bricker & Eckler, LLP - Columbus, OH



Telemedicine is an integral part of the healthcare world. Some states permit credentialing by proxy and some states do not. Some states have a strong peer review privilege and some states do not. This means that it is extremely important that the contract that is developed between "distant sites" and "originating sites" reflect not only compliance with CMS Conditions of Participation, but also that the contract reflects the reality of the responsibilities of the parties in light of the state requirements of the two sites.

This session will cover these areas and provide best practices for what needs to be included in these contracts.

- Describe the role of State law, Centers for Medicare and Medicaid Conditions of Participation and private accrediting entities in telemedicine credentialing, privileging and regulation.

Catherine Ballard is a 1985 graduate of The Ohio State University College of Law and is a partner at the law firm of Bricker & Eckler LLP in Columbus, Ohio. She works in the areas of hospital/medical staff integration, medical staff and hospital-employed physician integration, quality assessment and related peer review matters. Ballard develops medical staff governing documents and provides advice on accreditation, scope of practice, and general patient care. She is a regular speaker at national forums on these issues and others.

Session 6: Solving Our Patient Safety Crisis:A Practical Solution

John J. Byrnes, MD



Medical errors rank as high as third among causes of death in the United States, with 210,000 to 440,000 Americans dying each year from preventable hospital medical errors. Many organizations have made fantastic progress, but many are struggling. For example, the Leapfrog Group recently updated the results of its nationwide safety survey of hospitals and found that 40% received a C, D or F rating based on the Hospital Safety Score.

In this workshop, we'll review the top 10 strategies used by award-winning organizations to eliminate 90% of harmful medical errors.

Session 7: New Mexico Hospitals: Ensuring Access to Rural

Healthcare

Christina R. Campos, MBA, FACHE, Administrator, Guadalupe County Hospital - Santa Rosa, NM & Jim Heckert, CEO, Gerald Champion Regional Medical Center - Alamogordo, NM

With only 17 people per square mile, New Mexico is among America's least densely populated states. Deep understanding of the community and surrounding area, its culture, and its needs, as well as complex regulatory, financial, and economic dynamics are critical to the success of a rural hospital. Models that shape thriving rural hospitals are as diverse as the people for whom they provide access to care. Two New Mexico healthcare leaders from very different facilities will share strategies for providing services in a rural environment. Hear about challenging projects, lessons learned, and the role of the Board in achieving and maintaining success.



Robert J. "Jim" Heckert brings global experience including as Chief of Staff at Walter Reed Army Medical Center in Washington, DC, Administrator of U.S. Army Community Hospital in Vicenza, Italy, CEO of Daviess Community Hospital in Indiana, and now to this 100-bed facility in a micropolitan area of 30,000. Among his many accomplishments at GCRMC, he has grown physician practices from 3 to 18 with 43 providers, established a hospitalist program, brought comprehensive inpatient and outpatient Behavioral

Medicine services to the community and most recently established a Cath Lab at the hospital. Prior to arriving in New Mexico, Heckert served as the Chairman of the Indiana Hospital Association's Council on Rural Health. Currently he is New Mexico Hospital Association Board Chair.



Christina R. Campos has revitalized the 10-bed hospital, improving and expanding services, training local staff and eliminating "travelers," and spearheading construction of a patient-centered and high-tech replacement facility which opened in 2011. She serves on the U.S. HHS National Advisory Committee on Rural Health and Human Services, and recently served on the American Hospital Association's national Task Force on Ensuring Access in Vulnerable Communities. She is a past New Mexico Hospital Association Board Chair and serves now on its Board of Directors.

Bringing the Board to Quality

Steven Tremain, MD, FACPE, Physician Improvement Advisor, Cynosure Health Benicia, CA



The board receives and reviews multiple reports reflecting the hospital's business operations, including quality results. Yet, board members may not feel confident interpreting quality and patient safety reports and unsure what they can do to help the organization reduce patient harm.

This interactive session will provide participants with actionable "How to" approaches to move from information to improvement. The presentation will include an overview of the

Hospital Innovation Improvement Networks (HIIN), the model for improvement, the information and "actionable" data they should expect to see, tips for data and information interpretation, and the value of patient stories and "board rounds."

Dr. Steve Tremain is a physician improvement advisor for Cynosure Health. Board certified in Family Medicine, Dr. Tremain, has worked as a hospital-based clinician and teacher, and served as Chief Medical Officer for over 20 years. He was the executive sponsor for improvement teams that were awarded mentor status by the Institute for Healthcare Improvement in the areas of medication reconciliation, rapid response teams, and ventilator associated pneumonia. For the HRET HEN, Dr. Tremain is national clinical lead for harm reduction in the topic areas of adverse drug events, C difficile and VTE.

Coaching 2.0: How Trustees Can Support Taking the Patient Experience to the Next Level

Colleen McCrory, MBA, FACHE, Studer Group - Pensacola, FL



A critical success factor to leadership is the ability to coach. There is an "Art and Science" to exemplary coaching, which can be engaged by the hospital C-suite, as well as its board members. Leaders often sit comfortably in the science, but "Coaching 2.0" goes beyond the mechanics of running a successful hospital operation and giving generalized feedback. Today's healthcare leaders need to master the "art" of coaching to enable their staff to flourish in their development, reproduce rewarded behaviors, understand individual and collective opportunities for

development, and be able to demonstrate what "right looks like" all while holding staff accountable for greater levels of performance. Let's advance as leaders in the board room and move from coaching foundational tactics to coaching theory—the Art of Coaching 2.0!

- Articulate Support-Coach-Support approach to giving effective feedback.
- As a leader be able to effectively coach beyond competency assessments to skill development.

Colleen McCrory, a healthcare executive with more than 18 years of experience, is focused and passionate about facilitating change and developing high-performance teams. McCrory first joined Studer Group in 2011 as a coach. Most recently, she returned to Studer Group in 2016 after serving as the Chief Experience Officer for the nation's ninth largest public hospital, Broward Health Medical Center. McCrory led the patient and family-centered care model encompassing: patient satisfaction,

patient advocacy, complaint and compliment management, volunteer services, concierge services and overall customer service. Coupled with her Studer Group coaching experience, she served as the key subject matter expert and advisor to CEOs in improvement initiatives surrounding value-based purchasing and HCAHPS performance, evidence-based leadership, employee engagement and physician satisfaction. Her quick results and ability to influence organizational culture led to an interim role as COO for the 1.2M square-foot facility with over 750 beds and an average daily census of 525. She was recognized by the South Florida *Business and Wealth Magazine* as an "Up and Comer in Healthcare," in 2015.
